PEDESTRIAN ROUTES FOR RESIDENTS

Residents travelling to and from properties located outside the three designated footpath closure areas are requested to allow additional time for their journey and to use one of the signposted alternative routes around the venue.

Access points to the three designated footpath closure areas will be controlled by pedestrian barriers and event stewards with instructions to allow free pedestrian access to and from properties located within the footpath closure areas for residents and their guests or visitors, and to direct residents seeking access to properties outside the footpath closure areas to use the signposted alternative routes.

At busy periods, as the runners assemble before the start of the race or during the peak finishing time, residents may be asked to wait for 5-10 mins outside footpath closure areas to allow runners or spectators to safely disperse before being admitted by stewards. Stewards have a responsibility to prevent overcrowding or injury during the event, and in emergency they have legal powers to close pavements and refuse access to public and residents.

ZONES A — E (WHITE)

Nos 54 to 74 Great Pulteney Street (south side)

William Street (both sides)

Pulteney Mews west of William Street

Footpaths outside these properties will be closed to the public (and to residents of other adjacent properties) throughout the event from 08.00 – 15.30hrs.

Residents' access to these properties will only be restricted from 10.30-11.30hrs whilst the pavements are crowded for the runners' assembly before the race start, and again from 13.00-14.00hrs during the peak race finish.

ZONE F (GREEN)

Nos 7 to 12 Laura Place

Johnstone Street (both sides)

Nos 75 to 77 Great Pulteney Street (south side)

ZONES G & H (ORANGE)

Nos 1 to 16 Henrietta Street (west side)

Nos 1 & 2 Bathwick Villas

Residents' and public access to these properties will only be restricted from 10.30-11.30hrs whilst the pavements are crowded for the runners' assembly before the race start, after which all restrictions will be removed.

As agreed with PERA we will be delivering 2 passes to each property within the footpath closure areas. These will assist stewards in quickly identifying residents from these effected properties. Residents are completely free to request access to their properties without providing identification or a pass, but will be asked for details of the address they wish to access, to distinguish them from the public, or from residents whose properties can be reached by following one of the diversion routes around the closures.

IMPORTANT INFORMATION FOR PULTENEY ESTATE RESIDENTS

BATHHALF 2018

SUN 4 MARCH

Arrangements for this year's race are largely unchanged from last year.

This leaflet provides specific advice to residents and businesses within the Pulteney Estate, the area most effected by the Bath Half Marathon.

To prevent overcrowding, and to ensure the safety of competitors and spectators attending the event, road closures, parking suspensions and footpath closures will operate on a number of streets adjacent to the start & finish of the race in Great Pulteney Street, by legal order from Bath & North East Somerset Council. Warning signs will be put up on effected streets several weeks before the race, and further signage will be erected on signposted diversion routes around the city on race day itself, both for traffic and pedestrians.

Competitors and spectators travelling to the assembly area on Bath Recreation Ground will be directed to use the gate at the rear of the Sports Centre car park, off North Parade Road. No access will be available to the Recreation Ground from either William Street or from the riverside path, except for Pulteney Mews via Edward Street.

The race organisers, competitors, spectators, charities and event partners are grateful for the continuing support for the event from local residents and businesses, particularly the residents of the Pulteney Estate and adjoining streets. We work closely with Bath & North East Somerset Council, and other agencies to reduce the inevitable inconvenience caused by the event. We welcome constructive criticism and suggestions for improvements to the event to further minimise disruption.

Access arrangements for residents and contractors working arrangements during the set up and break down period for the event have been discussed in detail with representatives from the Pulteney Estate Residents Association ('PERA').

All restrictions quoted apply to Sunday 4 March, unless otherwise stated.

VENUE ROAD CLOSURES, PARKING SUSPENSIONS & FOOTPATH CLOSURES

Parking will be suspended in designated streets and 'No Loading' restrictions imposed. Vehicles remaining parked on designated streets will be towed away to a secure compound in Bath by council contractors and only released on payment of a fixed penalty notice of £70 and removal charge of £105 (plus storage charge of £12 per day for unclaimed vehicles).

Closures and suspensions apply to all vehicles including residents parking permit holders, parking meter and disabled ('Blue Badge') parking.

08.00-15.30hrs

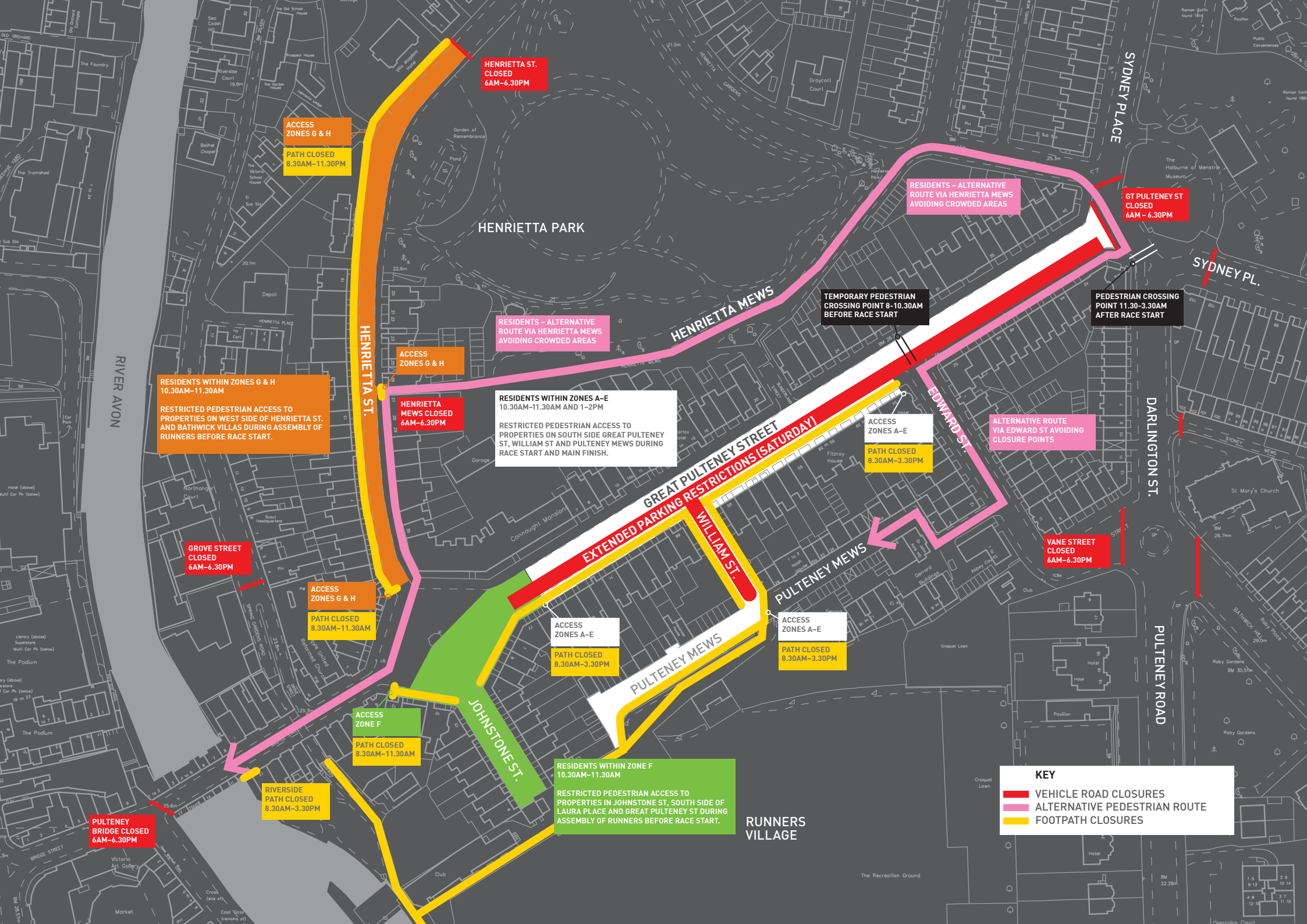

Extended Parking Suspension

12.00hrs Sat 3 March– 18.30hrs Sun 4 March
Great Pulteney Street south side and William Street.

To facilitate the erection of the medical marquee, stage, commentary cabin, grandstands and deliveries, reducing contractors' noise early on race day morning.

Traffic restrictions and partial footpath closures will also apply during the erection of equipment
